

LED Lamp Warranty

Savegreen Lighting warrants their Savegreen Lamps will be free of defects in material and workmanship and comply with their respective published specifications, from the date of installation, for the time periods outlined below and subject to the terms and conditions below.

Your lamp, when delivered to you in new condition, in its original packaging, including all parts and components thereof, is warranted against defects in materials or workmanship as follows for a period of five (5) years from the date of original purchase or 50,000 hours, whichever occurs first except for **Savegreen's Premium Series** of LED Lamps that have a ten (10) year warranty period if registered within 30 days of installation or 90 days from date of purchase whichever is earlier, at **www.savegreenlighting.com/warranty**. If registration isn't completed within 30 days, the standard five (5) year warranty will apply. The Limited Warranty covers units that have completely failed and does not apply if the failure is caused or contributed by any of the following:

- a. Improper installation, storage or failure to follow operating instructions
- b. Improper maintenance
- c. Repairs or alterations not authorized or performed by Savegreen
- d. Accident, damage, abuse or misuse including environmental applications
- e. Abnormal or unusual operating conditions or applications
- f. Electrical current surges
- g. A purpose or application in any way different from that for which the product was designed.
- h. SavegreenLamps used with fluorescent ballasts must be operated with ANSI-compatible ballasts. Ballast factors over 0.99 will have a reduce warranty of 48 months.

If lamps fail to operate for the warranty period, Savegreen will, at its sole discretion, provide a free replacement lamp (but no labor allowance) or issue a credit for future purchase.

WARRANTY CLAIM

To make a warranty claim, contact your Savegreen sales representative or authorized Savegreen Partner within 30 days. Keep the failed products which may be required to be returned for evaluation at Savegreen Lighting's discretion.

TERMS AND CONDITIONS

- Savegreen Lighting reserves the right to examine all failed lamps and reserves the right to be the sole judge as to whether any lamps are defective and covered under warranty.
- 2. The Savegreen Warranty shall be the sole remedy of the Customer and the sole liability of Savegreen Lighting to the Customer. No implied statutory warranty or warranty of merchantability or fitness for a particular purpose is made or is to be implied. Savegreen Lighting will not under any circumstances whether as a result of breach of contract, breach of warranty, tort, strict liability or otherwise be liable for consequential, incidental, special or exemplary damages including, but not limited to, loss of profits or revenues, loss of use of ballasts or any other goods or associated equipment to damage to any associated equipment, cost of capital, cost of substitute products, facilities or service, down time cost, or claims of claimant's customers.
